

# LIMITED WARRANTY

This log splitter is guaranteed to be free from defects in material and workmanship for the normal service life of the product not to exceed 36 consecutive months from the date of purchase. The cylinder, valve, pump and other hydraulic components are guaranteed for one (1) year from the date of purchase. The engine is covered under a separate warranty provided by the manufacturer and is enclosed with the owner's manual. SpeeCo will repair or replace free of charge any part or parts of the log splitter that are judged to be defective in material or workmanship during the limited warranty period stated above. The limited warranty does not cover parts that in the judgement of the manufacturer have been subjected to negligent use, misuse, alteration, accident, disassembled in any way or if repairs have been made by anyone except an authorized SpeeCo service center. Warranty claims must be submitted within thirty days of the date of failure with the log splitter identification number stated on it. Defective parts must be returned through an authorized SpeeCo dealer and transportation charges to the factory must be prepaid. The attached warranty registration card must be returned to SpeeCo for validation.
